i. Volunteers Update...Josh Russell

The City of PS and PSGSL are hosting a free community event for 200 underserved children and their families on Dec 18 at the PS Pavilion. With \$7K in donations from BMW of Palm Springs, Contour Dermatology and PSGSL, every child that attends (ages 5-12) will receive a new toy for the Holidays. Coverage has already appeared on NBCPalmSprings.

b. 2022 Practice Fields At Demuth Park... Scot Howard

PSGSL is working with Parks & Rec to cover the cost of practice fields for one month – either Feb or Mar. We will coordinate the scheduling so that all teams have equal access to fields and practice times.

c. 1-Day Masters Inter-League Play...Scot Howard

We are exploring interest in a 1-day tournament, similar to the annual A/B Inter-League play, for Masters teams within the SoCal region.

e. PSGSL Code of Conduct Update...Scot Howard/Brian Thompson

i. Unsportsmanlike Conduct

The PSGSL rule regarding unsportsmanlike conduct applies to Umpires as well. Our umpires have noticed a change in how they are being treated and as such many no longer enjoy working with our League. If umpires are not willing to work with us, then we don't play ball. Therefore, PSGSL umpires have been instructed to give each team one warning if a situation arises. Afterwards, a player and/or coach may be objected if deemed necessary by the umpire. Anyone ejected for arguing, yelling, bad-mouthing an umpire will be suspended for the remainder of their games that day and all games the following week.

ii. Team Eligibility

PSGSL ByLaws Article IV: Members: Teams representing PSGSL may only include a maximum of 3 non-LGBT players as per NAGAAA guidelines.

It's been brought to the Board's attention that this rule isn't being enforced. According to one source, non-LGBT players are being told to simply "check the box" and their frustration with the League is growing when they repeatedly see LGBT players sitting the bench, while more than 3 non-LGBT players are on the field.

Investigating this assertion, the Board reviewed the "status" checked by the 226 players for The 2021 Fall Season. 21 had checked non-LGBT, which is 9% of the total players this past season, meaning that with 14 teams no more than 2 non-LGBT players would be on the field for a team.

We also have a coach present that has similar concerns that would like to address the Council....(please see last page for a copy of the statement presented to the board)

The Board's position on non-LGBT players:

The PSGSL was not formed just to be another softball league. There is a reason Tommy (Our Founders) included Gay in the title. Their mission was to provide a safe, fun environment for everyone but with a strong emphasis on, using their words, "...members of the Gay and Lesbian community" in Palm Springs.

That said, the Board does not want to discourage non-LGBT members playing in our League but would like to see these individuals be more immersive in and supportive of gay-themed activities off the field like marching in the PRIDE parade, attending team events on Arenas, etc.; rather than just showing up on a Sunday and playing softball. For example, I can count the number of non-LGBT members that marched in this year's PRIDE parade on 1 hand.

9. Good of the Order/Announcement

Firstly I want to commend Peter Ho and the other PSGSL members who did a fantastic job with the tournament a couple of weeks ago. Over Turkey Shootout weekend, the Thunderbirds team felt compelled to do something we had great reservations about. That is protesting another team. Since moving to California in 2005 till now I had not filed a protest against another team. That covers a span of 15 years. My lone protest prior to this was back in the 90's in Florida, over 20 years ago. In the events here we strongly felt this team had at least one unrated player who undoubtedly belonged in the C Division. Perhaps the bigger issue. Over time I have witnessed teams stacking up with heterosexual players. I feel this is largely due to the ease of being able check "questionable" as a sexual designation. As one former PSGSL player/manager put it, "You can't question me". There seems to be continued pushing of the limits of the 3 heterosexuals per team rule. When I asked someone who I trust implicitly, that knows this team well whether they were abiding by the "3 per", they counted at least 7 participants that he knew to be heterosexuals. This was really upsetting to me as we had previously turned a blind eye to obvious breaking of the rules. Now not only were the sexual preference for the vast majority of the team in doubt, but the abilities of the unrated players were also in serious question.

I've been involved with gay softball since 1995. Back then it was actually an 80/20. As gay acceptance has grown it seems only natural that there is an increase in participation of heterosexual players. Without throwing out accusations towards anyone or any team, it has simply gotten too easy to lie and some have no reservations about doing so. When I was taking a team to the World Series in Portland I wanted to pick up a player from another team, but knew he was heterosexual and we were already at our cap. When I lamented about this to his coach, he replied, "He checked the box and that can't be questioned". Ethically I couldn't bring myself to do this. Unfortunately this seems to be a growing issue. I also feel sadness that many of these people who perhaps should be designated as heterosexuals aren't heterosexuals that are necessarily there to support their Gay, Lesbian and Transgender brothers and sisters. Rather I've previously overheard a current player state that it's the cheapest softball deal in town. Then you look at participation marching in Gay Pride and it's non existent for some teams. Though I've not experienced this first hand, I've even heard there are players in PSGSL who do not want to take photos to have their faces put on a gay website. This is outrageous. To me, the 3 heterosexual per team rule is what integrates heterosexuals in the gay community. As gay people many of us have experienced being the minority in different facets of life. Being a participant in a gay league allows us the comfort of being around other gay players. I believe the intention of admitting heterosexuals is that they feel a connection with us. Mike Landin is a close friend and the person I run a senior league with. His wife Teri and my partner Peter go out to lunch and movies while Mike and I are at tournaments. Jerry Contreras has been playing for me for well over 10 years. We have roomed together and he has slept at my house for early flights as I'm near the airport. I affectionately call him "my son" because if I had a son I'd want him to be just like Jerry. It's not just about softball with these guys.

What should be done. There are two courses of action. The first is untenable. That is to open it up so ALL TEAMS can have as many heterosexual players as they desire. This way there is no cheating. The second way is to change the sexual preference wording on player forms so it reads, "*The majority of the time* I consider myself to be gay, lesbian, transgender, bisexual or heterosexual". The current verbage causes too much of grey area which is exactly what people who are solely looking to beat the system want. The Rounders have won multiple World Series titles in the "A" division playing by the rules. Finding "A" level players is much, much more difficult task then those in the C, D and E divisions. How is it that Jeff and the Rounders can do the right thing and yet there is the ability to ignore rules in the lower divisions?
