In consideration for my being permitted to participate in the activities of Palm Springs Gay Softball League (PSGSL), I knowingly and voluntarily agree to the following Waiver and Release:

I acknowledge that any form of participation in softball has inherent risks and dangers that include but are not limited to risk of physical injury or bodily damage, property loss, disability, paralysis or death. Participation includes engaging in softball practices or drills, engaging in scheduled league games at any location, including but not limited to "Big League Dreams" in Cathedral City, California or "Demuth Park" in Palm Springs, California and/or spectatorship or volunteer assistance at any such event. Participation also includes the risk to have contact with individuals who have been exposed to and/or have been diagnosed with one or more communicable diseases, including but not limited to Covid-19 or other medical conditions, diseases, or maladies does exist, and it is impossible to eliminate the risk that I could be exposed to and/or become infected through contact with or close proximity with an individual with a communicable disease. My participation in this activity is purely voluntary, and I knowingly and voluntarily elect to participate and hereby assume and accept any and all risks potentially associated with this activity.

I, for myself, my heirs, successors, executors, and subrogees, hereby knowingly and intentionally waive and release, indemnify and hold harmless Palm Springs Gay softball league (PSGSL), its board of directors, officers, agents, employees, volunteers and team or league sponsors, from and against any and all claims, actions, causes of action, liabilities, suits, expenses (including reasonable attorneys' fees) which are related to, arise out of, or are in any way connected with my participation in this activity including, but not limited to, causes of action for negligence of any kind or nature, whether foreseen or unforeseen, arising directly or indirectly, and resulting in any damage, loss, injury, paralysis, or death to me or my property as a result of my engaging in these activities or using these services or equipment. This waiver, release, indemnification and hold harmless applies to all such potential causes of action, including those in which such damage, loss, injury, paralysis or death results from the negligence of Palm Springs Gay softball league or from some other cause. I, for myself, my heirs, my successors, executors and subrogees, further agree not to sue Palm Springs Gay softball league as a result of any injury, paralysis, or death suffered in connection with my participation in the activities of Palm Springs Gay softball league.

I further acknowledge and agree that the Board of Directors of PSGSL may contact me (using e-mail or any other form of communication you have provided) regarding league-related or other issues.

I further specifically agree that PSGSL may use my photographic image in any Web Site or community promotions or publications.
